He commented that many of the processes and procedures that were recommended are already in place for our district. Also, we had several individuals and local organizations donate to relieve the district's student lunch debt.

BOARD COMMUNICATIONS SUPERINTENDENT'S REPORT

Superintendent Palmer reminded the Board of Education of the high school orchestra concert tomorrow night, and of the play off game that the high school football team with play at Mason on Friday night.
